Surface Preparation

Remove by appropriate means grease, oil, mill scale, corrosion deposits, weld slag, spatter, or other surface contamination.

Application Equipment

The following equipment is listed as a guide and suitable equipment from other manufacturers may be used. Adjustments of pressure and change of tip size may be needed to obtain the proper spray characteristics.

AIRLESS SPRAY - Standard airless spray equipment using tip size 0.11" to 0.14".

Dilute with Thinner 21-06 only as required to achieve an even spray pattern (5-10% max)

CONVENTIONAL SPRAY – Standard Industrial equipment. Separate air and fluid pressure regulators. Mechanical pot agitator and a moisture and oil trap in the main air supply line are recommended. Dilute with Thinner 21-06 only as required to achieve an even pattern (5-10% max)

BRUSH / ROLLER - For touch up purposes.

MIXER - Use power mixer powered by an air motor or an explosion proof electric motor.

Application Procedure

OA 9553 is a one component product and packaged in a 20 ltr or 200 ltr unit.

- 1. Mix material thoroughly.
- Thinning of up to 5-10 % (max) by volume may be necessary to create an even spray pattern. For brush application do not add thinner, except to compensate for evaporation of solvents from the container.
- 3. Application 25 microns dry film thickness per coat.
- 4. Ventilation with air is required during application and drying
- 5. Spray on a heavy, wet coat, making even parallel passes. Overlap each pass 50% to achieve an even spray patter and to avoid pinholes, bare areas and holidays.
- 6. Double-lap spray all corners, welds, rough spots, edges, etc.
- 7. Clean all equipment after application with Thinner 21-06.

Repair

If coated surface is superficially damaged, lightly sand to feather damaged areas and apply 2 coats of OA 9553. If damaged to bare metal, apply primer as suitable and top coat with 1 or 2 coats of OA 9553. When repair is carried out by brush and in case of evaporation loss, thin with 5- 10 % (max) on volume of Thinner 21-06.
