OA 9564-F.D. is a one component product and packaged in a 20 ltr or 200 ltr unit.

- 1. Mix material thoroughly.
- 2. Thinning of up to 10 % (max) by volume may be necessary
- 3. Application25-50 microns dry film thickness per coat is to be advised.
- 4. Ventilation with air is required during application and drying
- 5. Clean all equipment after application with Thinner 21-06.
